

IMPORTANT UPDATE! BCBSAZ will continue the post-acute preservice review waiver until further notice

In response to the unexpected impact of increased COVID-19 cases and concerns about hospital capacity across the state, Blue Cross® Blue Shield® of Arizona (BCBSAZ) will continue the waiver of preservice reviews for transitions from acute care to post-acute care facilities. This is a change from the message in our November 11 email notice about discontinuing this waiver effective December 15, 2021. We have updated our plans and will keep this waiver in place until further notice.

Reminder: On November 15, we removed member cost-share waivers for telehealth services *not* related to COVID-19 testing. We have added a cost-share waiver for monoclonal antibody treatment. See the updated list below for details.

Preservice review waiver for all transitions from acute care to post-acute care facilities (SNF/EAR/LTAC) <i>You must notify BCBSAZ within 72 hours of admission and send medical records within three days for concurrent review.</i>	Most BCBSAZ commercial plans (excludes self-funded groups with customized prior authorization requirements) Federal Employee Program® (FEP®) plans BCBSAZ-administered Medicare Advantage (MA) plans (<i>not</i> those administered by P3 Health Partners and Arizona Priority Care)	UNTIL FURTHER NOTICE
NOTE: For the duration of the public health emergency, the transfer of a patient with, or suspected of having, COVID-19 from an emergency room to a different facility through the ADHS Arizona Surge Line does <i>not</i> require prior authorization (regardless of the receiving facility's network status). This applies to patients with benefit plans that are regulated by the Arizona Department of Insurance (e.g., fully insured BCBSAZ group and individual plans).
